### REGISTRATION INSTRUCTIONS

**Step 1: PURCHASE YOUR MEMBERSHIP:** For athletes, general members, staff, Board Members, and youth and club members to purchase their individual or group membership. Please use your current Sports Engine Account or [create a new account](#) for new members.

**Step 2:** Upon purchase, you'll receive an email to help finalize your membership. All adult members who are coaches, educator and, board members, and athletes are required to complete the following within 6 weeks of purchase.

Coverage applies to all registered members against accidental death and dismemberment and provides excess medical benefits as listed.

- \$5,000,000 Commercial General Liability (each occurrence)
  - Includes participants, instructors, coaches, and sport officials
- \$5,000 Medical Expenses (Any one Person)
- \$1,000,000 Personal & Advanced injury
- \$5,000,000 Commercial Property Liability
- Director & Officers Coverage
- \$1,000,000 Abuse and Molestation
- Automobile Liability
