REGISTRATION INSTRUCTIONS

Step 1: PURCHASE YOUR MEMBERSHIP: For [athletes](#), [general members](#), [staff and Board Members](#) and [youth](#) and [club](#) membership to purchase their individual or group membership. Please use your current Sports Engine Account or [create a new account](#) for new members.

Step 2: Upon purchase you'll receive an email to assist with finalizing your membership. Child of this Culture Foundation requires that you complete all of your eligibility requirements before participating. All adult members who are coach, educator and board members and athletes are required to complete the following within 6 weeks of purchase.

Requirements training can be completed or resumed at any time.

Eligibility Requirements are:

1. Abuse Prevention Systems
2. Background Screening

Step 3: Once completed and passed your account will update automatically. No further action required. *Your status will remain pending until all items are updated.*

Coverage applies to all registered members against accidental death, dismemberment and provides excess medical benefits as listed.

Limits:

- \$5,000,000 Commercial General Liability (each occurrence)
 - Includes, participants, instructors, coaches and sport officials
- \$5,000 Medical Expenses (Any one Person)
- \$1,000,000 Personal & Advanced injury
- \$5,000,000 Commercial Property Liability
- Director & Officers Coverage
- \$1,000,000 Abuse and Molestation
- Automobile Liability
